RULES FOR ANNUAL REWARDS TO MERITORIOUS FEDERATIONS

Every year, the 10 most deserving Federations as for their international activities and the respect of deadlines will be awarded a cash reward (CHF), as well as a recognition diploma, based on the following criteria. The Federations sanctioned during the current year will automatically be excluded from the ranking.

A sum of CHF 75'000.-- will be allocated every year and the Presidential Commission will be empowered to assign it.
