

## APPENDIX 3

<b>CRITERIA FOR INCLUSION IN THE 2016 REGISTERED TESTING POOL</b>
---

1. According to Article 5.6.1 of the FIG Anti-Doping Rules, FIG shall identify a Registered Testing Pool (“RTP”) of those Gymnasts who are required to comply with the whereabouts requirements of the International Standard for Testing.

2. The FIG RTP will be established at the end of each year to come in force on the 1<sup>st</sup> of January of the following year. It may be updated during the year. It will be published on the FIG Website.

3. The FIG 2016 RTP shall be established of:

**(a) the Gold Medallists of the World Championships:**

- **2015 Trampoline (TRA)**
  - Women’s Tumbling
  - Men’s Tumbling
  - Individual women
  - Individual men
  
- **2015 Men’s Artistic Gymnastics (ART)**
  - Men’s Floor
  - Men’s Pommel Horse
  - Men’s Rings
  - Men’s Vault
  - Men’s Parallel Bars
  - Men’s Horizontal Bar
  
- **2015 Women’s Artistic Gymnastics (ART)**
  - Women’s Floor
  - Women’s Vault
  - Women Uneven Bar
  - Women’s Balance Beam

**(b) One athlete drawn among synchronised trampoline Gold Medallists of the World Championships:**

- **2015 Trampoline (TRA)**
  - Women’s Synchronized
  - Men’s Synchronized

**(c) First place of the World Ranking:**

- **2015 Aerobic (AER)**
  - Men’s Individual
  - Women’s Individual

**(d) One athlete per team drawn among the first place of the World Ranking:**

- **2015 Aerobic (AER)**
  - Mixed Pair (2)

**(e) One athlete (base) per pair among the first place of the World Ranking:**

- **2015 Acrobatic (ACRO)**
  - Mixed Pair (2)
  - Women's Pair (2)
  - Men's Pair (2)

**(f) the Gold, Silver, Bronze Medallists, the 4<sup>th</sup> and the 5<sup>th</sup> place of the World Championships:**

- **2015 Rhythmic Gymnastics (RG)**
  - Individual All-Around
- **2015 Women's Artistic Gymnastics (ART)**
  - Individual All-Around
- **2015 Men's Artistic Gymnastics (ART)**
  - Individual All-Around

**(g) The Gymnasts previously on the FIG RTP who had retired and who intend to return to competition, in accordance with FIG Rules.**

4. Should a Gymnast already selected appear in another category, the next eligible Gymnast will not be selected.

5. FIG may add any gymnast to the RTP during the year.

6. The above criteria are subject to amendment as needed.
